In order to reduce paper use, please note that this application can be filled out on your computer. Save a copy to your hard drive for your records and email it back to info@celebratehighwood.org.

- A "Food Vendor" is any vendor that samples, serves and prepares food items made to order.
- **Vendors may not sell alcoholic beverages of any kind.**
- Spaces are 10' x 10' and **include 1.) a tent and 2.) electric up to 20 amps.**
- Any larger space will be charged an additional fee (see PAYMENT SCHEDULE below). This will be strictly enforced.
- Vendors are required to provide their own lighting, heat source and electrical cords which must be UL approved and outdoor grade.
- Additional electric will be provided at a rate of \$50 for each additional 20 amps (see PAYMENT SCHEDULE below).

- ✓ If applicable, a **Lake County Health Department Certificate** associated with the preparation and serving of your food product.
